

OFFICIAL RULES

Void outside the 50 United States, District of Columbia and where prohibited. Must be at least 21 years of age and a legal resident of, and located within, one of the 50 United States or the District of Columbia, at the time of entry. By participating, you agree to be bound by these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Sweepstakes.

SWEEPSTAKES PERIOD: The TriGreen Open House Sweepstakes (“Sweepstakes”) begins at 8:00 a.m. Central Time (“CT”) on 04/22/16 and ends at 1:00 p.m. CT on 04/23/16 (“Sweepstakes Period”).

SPONSOR: TriGreen Equipment, 1776 TriGreen Drive, Athens, AL 35611 (“Sponsor”).

HOW TO ENTER: During the Sweepstakes Period, visit any of the eighteen (18) TriGreen Equipment locations and follow the instructions provided to submit a completed entry form, while supplies last, to receive one (1) entry. There is no cost to register or enter. Entries by mail will not be accepted. Entry forms that do not include all required information or that include ineligible information will be void. All entries must be submitted by 1:00 p.m. CT on 04/23/16 to be eligible. All entries become the property of Sponsor and will not be returned.

LIMIT: One (1) entry per person throughout the Sweepstakes Period. Entries received from any person in excess of the stated limitation will be void.

If such documents are not returned within the specified time period, Sponsor is unable to contact potential winner within two (2) days of the drawing, or potential winner is not in
